NOTIFICATION

S.O..... In exercise of the powers conferred by sub-section(2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act.

a) In the said First Schedule against "Pt. B.D. Sharma University of Health Sciences, Rohtak, Haryana" and under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Bachelor of Medicine and Bachelor of Surgery"

MBBS

(This shall be a recognised medical qualification when granted by Pt. B.D. Sharma University of Health Sciences, Rohtak, Haryana in respect of students being trained at Shree Guru Gobind Singh Tricentenary Medical College Hospital & Research Institute, Gurgaon with annual intake of 100 MBBS students on or after December, 2014.

- Note to all:
1. The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
 2. The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
 3. Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute/medical college.
